SUMMARY ANNUAL REPORT FOR THE IRON WORKERS OF WESTERN PA PROFIT SHARING PLAN

This is a summary of the annual report for the Iron Workers of Western PA Profit Sharing Plan, Employer Identification Number 25-1318890, for the period January 1, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the Plan are provided by a Trust. Plan expenses were \$21,782,685. These expenses included \$600,050 in administrative expenses, \$66,000 in investment manager fees, and \$21,116,635 in benefits paid to participants and beneficiaries. A total of 2096 persons were participants in or beneficiaries of the Plan at the end of the year, although not all persons had yet earned the right to receive benefits.

The net assets of the Plan, after subtracting liabilities, was \$207,227,132, as of December 31, 2022, compared to \$237,520,804, as of January 1, 2022. During the Plan year, the Plan experienced a decrease in its net assets of \$30,293,672. This increase included unrealized appreciation or depreciation in the value of the Plan's assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year.

Including employer contributions of \$15,583,750, net gain from investments of \$5,629,274 and net loss from investments of \$29,724,011, the Plan had a total loss of \$8,510,987.

You also have the legally protected right to examine the annual report at the main office of the Plan (2201 Liberty Avenue, Pittsburgh, PA 15222), and at the U.S. Department of Labor in Washington, DC or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
